## **CALL FOR POSITIONS OF RMO & STAFF NURSE IN NITC HEALTH CENTRE (COVID-19)**

1. The Institute proposes to prepare a panel of qualified and experienced personnel to engage in the posts of Resident Medical Officer and two Staff Nurses in the Institute Health Center for a period of six months from the date the campus reopens for on-campus academic activities. The engagement is purely on contract/temporary basis and is for the Institute's requirement for dealing with COVID-19 situation in NITC Campus. The post is not against any regular post, therefore does not have any claim, implicitly or explicitly for any regular post in NIT Calicut.
2. Interested candidates with the qualifications as specified below may apply by filling the [registration form](#). The registration form along with photocopies of relevant documents in support of your claims for applying for the post must be forwarded to the Institute to the address: **Assistant Registrar (Establishment), NIT Calicut, NIT Campus PO, Kozhikode 673601**. The application form along with the its enclosures must reach the Institute by 27<sup>th</sup> August 2020, 4:00 PM. Please note that the applications are to be sent by post.
3. The candidate's whose applications is received within the last date (27<sup>th</sup> August 2020) and considered eligible for selection process will be informed regarding the same in due course. The candidates thus called for, will be required to produce the originals in support of their claims along with proper id proof.
4. Only certificates from Government or Government recognized institutions will be accepted. Due consideration will be given to SC/ST/OBC/EWS/PH candidates as per Govt. of India rules on production of valid certificate issued by appropriate authority as per Central Govt. norms. Candidates without original certificates as against their claims will not be permitted to take part in the selection process at any cost or considered for appointment. No TA/DA will be paid for appearing for the selection process. The crucial date for consideration of age limit is 1<sup>st</sup> August 2020.
