#### **All the candidates should have either of the following certificates at the time of reporting**

1. Certificate showing that he/she has taken at least the first dose of COVID vaccination
2. Certificate/Report of the RTPCR test taken within 72 hours of the reporting date.

The candidates will have to come, report and leave the campus on the same day. The institute will not be arranging any facilities for the stay of the candidates.

**You can come to the security gate on the day of reporting and you will be directed by the security personnel to the venue.**

The List of Original Documents to be produced at the time of Physical Document Verification is also given. **Please make sure that all the original certificates as indicated in the list given and the certificate for ensuring COVID protection as indicated above are there with you, before you come for reporting.**

#### **Note to "Appearing" Candidates:**

Please note that the schedule contains "Appearing" (2021 passing out) candidates also. But those candidates whose results are not declared yet, need not come and report as per the schedule. We will be providing an alternate day for all such candidates. Candidates whose results are already declared and all the relevant documents (the mark sheets of all semesters, provisional degree certificate, Transfer Certificate and Character/Conduct certificates) are available can come and report as per the schedule.

#### **Note to Candidates who have got allotment in a different institute during the Special Round 3 (SRNSR):**

Those candidates **who have participated in Special Round 3 conducted by CCMT/CCMN** and got allotted to another institute need not report as per the schedule. If any such candidates have already sent their original Transfer/Migration Certificate and Character/Conduct certificates, you can send a mail to the PG admission office along with your full address to which the certificates are to be returned.

#### **List of Documents to be produced for Physical Document Verification**

- (a) Document for Proof of date of birth.
- (b) Photo ID proof as per Govt. of India norms.

- (c) Mark sheet of Class XII/ Diploma certificate and mark sheets in case of lateral entry candidates.
- (d) Grade/Mark sheets of qualifying examination for all semesters (Consolidated Grade (Mark) sheet with all subjects mentioned in it).
- (e) Degree/ Provisional certificate.
- (f) GATE/JAM score card (2019 or 2020 or 2021).
- (g) Certificate for Economically Weaker Sections, if applicable, issued by the competent authority (not below the rank of Tahsildar) indicating the financial status for the financial year ending March 31, 2021 (2020-21) **(should have been issued on or after 1<sup>st</sup> April, 2021)**.
- (h) Community Certificate, in the case of OBC candidate, from a competent authority (not below the rank of Tahsildar) indicating the status regarding Creamy Layer based on financial year ending March 31, 2021 **(should have been issued on or after 1<sup>st</sup> April, 2021)**.
- (i) Community Certificate, in the case of SC/ST candidate, from a competent authority (not below the rank of Tahsildar).
- (j) Certificate from the Medical Board of Govt. Medical Colleges/Dist. Head Quarters Hospitals, in the case of Persons with Disabilities (PwD).
- (k) Transfer or Leaving Certificate issued from the institute last studied/attended. You can submit the Migration certificate instead of the Transfer certificate, only if the Institute/University is autonomous/ Deemed or the institute is not providing the same. In that case you need to submit a proof issued from the institute last studied/attended stating that they do not issue a transfer certificate
- (l) Conduct/Character certificate from the Head of the Institution/Organization last attended/working or Gazetted Officer **issued within last six months (Should have been issued on or after 1<sup>st</sup> February 2021). If character is indicated in the transfer certificate, please make sure that the Transfer certificate is issued after 1<sup>st</sup> February 2021, otherwise you must produce a separate certificate for character/conduct.**
- (m) One passport size photograph.

**Note: Those who have already sent their original Transfer and/or Migration and character/conduct certificates need not bring the same.**
